The Chairman, Senate Post Graduate Committee (SPGC) welcomed the members. Agenda items were then taken up for consideration.

Item No.1 To receive and confirm the minutes of the 3^{rd} meeting held on 07/01/2016 as circulated on 12/01/2016.

The minutes of the 3rd meeting held on 07/01/2016 as circulated on 12/01/2016 was confirmed.

Item No.2 Agenda Points & Notes from SPGC to be put up in 4th Senate were discussed.

Point No.1 - To discuss the modalities with reference to the new proposed M.Tech. Program to be started from the next academic session, 2016-17.

[With reference to the minutes of the 3^{rd} Meeting of the Senate (IIIT-A) Agenda Item No. 8 – Observations on salient points of 2^{rd} meeting of SPGC point No. 10]

Presently the Institute offers M. Tech.(IT) programs with 7 different specializations and M.Tech.(ECE) program with specialization in Microelectronics. Also, integrated M.Tech.-Ph.D. in each of these 8 specializations are already being offered. The seat matrix for the session 2015-16 for these programs is attached herewith at Annexure no. 1.1.1.

SPGC considered the proposals of DPGC (ECE) and DPGC (IT) as placed at (Annexure no. 1.1.2) After deliberations at length the SPGC felt since the issue of increasing of seat

- (i) The total number of seats in M.Tech. and Integrated M. Tech. Ph.D. programs in the Institute will be kept same.
- (ii) The ECE department was asked to give a self contained proposal for additional seats for further discussion in the senate. (Annexure: 1.1.3)

The seat Annexure as proposed by ECE department shown in Annexure 1.1.3 was objected to by HOD-IT. The sharing of seats of WCE was not agreed upon. It was therefore decided that ECE department requests for additional seats which may be placed for discussion and approval in the senate.

Point No.2 Reporting of the Change of Supervisor & completion of residency as per the approval of Chairman-SPGC (Annexure: 2)

The SPGC noted and accepted the approvals for change of supervisor; however the committee opposed the current policy of proposed allotment of co-supervisors for those students who have left the campus. For future such cases it was proposed that for students who have completed their residency or completed their open seminar and whose supervisor goes on a long leave then the Convener DPGC/ Chairman-DPGC would act as the *caretaker supervisor for the student.*

Point No.3 Adopting of MHRD GO F.No.17-2/2014-T.S.-1 dated 1^{st} September, 2015 regarding the Scholarship of PhD students (Corrections to the minutes of the 3^{rd} senate meeting Agenda Item No. 8 – Observations on salient points of 2^{nd} meeting of SPGC point No. 1])

As per the discussion in the 3rd Senate meeting held on 17/10/2015 it was decided that the transition from 04 years scholarship to 05 years scholarship as per the above mentioned GO would not be done automatically. The student will have to be assessed by a three-member committee constituted by the DPGC chaired by the supervisor, before final extension of the scholarship. *As this has been wrongly minuted as :*

 Adopting of MHRD GO F.No.17-2/2014-T.S.-1 dated 1st Sept. 2015 regarding the Scholarship of Ph.D. students and relook of programme length for various courses (as per the minutes of the 2nd Senate Meeting).

in the 3rd Senate minutes of the meeting therefore, this is for further ratification in the 4th Senate meeting.

Point No.4: Regarding approval of the Ph.D admission advertisement to be placed on the website

The advertisement of all the departments has been finalized keeping in mind the GO and the PG manual as approved by the senate. This is placed for further suggestions and ratification. (Annexure: 3)

A PhD selection brochure is compiled with all the details provided by the different DPGC's and circulated to all the faculties and PhD students. The corrected brochure to be placed before the senate for final approval.

Point No.5: Regarding Pg Manual –regarding appointment of external supervisor for the PhD Students. (PG manual-Point 11.1 page 24.)

As per the current PG Manual point 11.1 (pages 24) regarding appointment of thesis supervisor.

It is proposed that a provision for appointment of external supervisor for PhD students also be made in-order to promote inter-institutional interactions and research. The external supervisor would be proposed by the supervisor stating the expected quantum of contribution of the external supervisor and approved by the DPGC, subject to being reported to and accepted by the SPGC.

Point No.6: Regarding incorporating the title of the thesis in the PhD degree being awarded.

It is proposed that the title of the thesis be incorporated in the PhD degree being awarded. A sample copy of the certificate with location of the changes marked was approved (Annexure: 4)

Point No.7: Regarding printing of final thesis

It is proposed that the final thesis after correction be printed on both sides in-order to reduce shelf space and also for the economic use of paper. (1.5 spacing, 12 font, AK Bond paper, page no. center bottom)

Item No.3 Regarding the case of Mr. Purav Parikh

SPGC was of the view that since this was an administrative issue so the matter cannot be decided in the SPGC. Further the HOD-Management/ DPGC was authorized to explore the possibility of assigning a supervisor to the student. However, if no supervisor is ready to guide him in the department then a clear cut recommendation for continuation /cancellation of PhD Candidacy should be made.

Item No. 4 Reporting of scholarship extension of students after completing 04 years

Annexure-2 provides the list of students whose scholarship was extended beyond 4 years. The committee agreed to the view that the students need to apply for the financial extension well in advance of his completion of 04 years .No arrears will be given. (Annexure: 5)

Item No. 5 Reporting of change of supervisor & allotment of supervisors

The change of supervisors & allotment of supervisors for the new students was taken into cognizance. (Annexure: 6)

Item No. 6 Regarding relooking the advertisement flyers and a discussion to modify the current advertisement in line with the IIIT Kanchipuram advertisement as it is more informative and comprehensive.

All the members of SPGC were of the view that each department should separately develop a flyer for advertisement and it will be put on the IIITA website linked to a common interface. Print out of the flyers along with the brochure will be send to all the premium institutes of the country to attract good students

Year 2015: Minutes of the 2nd Meeting of the DPGC of the ECE Department (Venue: Room no. 2106, CC-1 Date: 1st Oct'2015 Time: 04:00PM)

The following resolution have been made after thorough deliberation:

1. The course of M.Tech.(EC) with specialization in Communication Engineering (CE) was started in July 2012 while the course of M.Tech.(IT) with specialization in Wireless Communication and Computing (WCC) was started in July 2002. In July 2014, the Senate decided to discontinue these two courses, and start a new course as M.Tech. with specialization in Wireless Communication Engineering (WCE) as an Inter departmental Program (IDP).

In last two years, it is found that the motive of this merging/opening is not being fulfilled. Hence, it is decided to close the M.Tech.(IDP)-WCE, and to restart the above two M.Tech. program. The curriculum of M.Tech.(EC)-CE and the seat matrix is attached herewith as Annexure-1 and Annexure-2 respectively. This should be placed before the Senate for its ratification.

- 2. Thesis Repository in case of PhD may be compulsory on Intranet, however, in case of Internet, it may be the choice of the Thesis Supervisor. While, in case of M.Tech. Thesis, the repository may be compulsory, but only on Intranet.
- 3. The matter of Mr. Nitin Goel (RS-111), PhD Student of ECE department, was discussed in the light of the comments received from his supervisors Prof. B. R. Singh and Dr. Neetesh Purohit. Both of them are of the opinion that the student may not be able to complete the requirement of PhD program. It should be communicated to the concerned student.

Agenda Item-10: Decision in various plagiarism cases as reported by Ph.D. Cell.

Resolution: The SPGC is requested to seek for the written explanations from the students and supervisor(s) on the issues reported. The same may be forwarded to DPGC for further discussions and necessary decision.

Agenda Item-11: Merging M. Tech. (WCC) and M. Tech. (CE) into M. Tech. (WCE) has been proved inappropriate. Thus, from the session 2016, the institute should discontinue M. Tech. (WCE) and again resume both original courses viz. M. Tech. (ECE) with specialization in Communication Engineering and M. Tech. (IT) with specialization in WCC. DPGC (ECE) and DPGC (IT).

Resolution: DPGC agreed in principle and same may be forwarded to Senate through SPGC for further approval.

Agenda Item-12: Any other agenda item with the permission of chair and convener.

Other Agenda Item-1: Discussions on publication/patent (Point No.4) and obligations of JRF/SRF (Point No.6.II) as per F.NO.17-2/2014-TS.I Government of India Ministry of Human Resource Development Department of Higher Education, Dated 18th Feb 2015.

Resolution: The discussion was done against the point number-4 & 6.II of above mentioned GO. The DPGC resolved against the points as follows,

(a) The results of JRF/SRF/M.E./M.Tech/MS/M.Design research work published in any journals must have appropriate acknowledgement for funding agency of Government of India (e.g. MHRD, GOI).

(b) The JRF/SRF/M.E./M.Tech/MS/M.Design must send a detailed consolidated report of the research work done during the entire period of fellowship on completion of the tenure/registration of the fellowship at earliest. The hard and soft copy of the report/thesis must be kept in the institute repository (library) with proper identification (indexing) and a list of such JRF/SRF /M.E. /M.Tech /MS/ M.Design, containing the Name, En./Reg. No., Title of Research Work (Thesis title), Duration of fellowship, and submission date must be prepared and displayed on Institute website appropriately. The submission in Institute repository must be ensured by DPGC (at department level) and may be ensured by SPGC (at Institute level).

Other Agenda Item-2: Preparation and circulation of poster for IT department for PhD admissions to attract good PhD students.

Resolution: The DPGC resolved to prepare the PhD admission related posters of IT department. This poster, contain the thrust areas, to be published from departmental fund and to be circulated in hard and soft forms to various good target institutes. Dr. Jagpreet Singh and Dr. S. Venkatesan have been requested to prepare the poster and address list of target institutions for circulation, in consultation with DPGC & HoD.

ECE Department

(New proposed M.Tech. Program to be started from the next academic session, 2016-17)

- (i) Merging of M. Tech.(IT) with specialization in WCC and M.Tech.(ECE) with specialization in Communication Engineering into M. Tech. (WCE) did not give desired results. Thus, it may be reverted as follows:
 - (a) M. Tech. (IT) with specialization in WCE should be renamed as M. Tech. (IT) with specialization in Wireless Computing (WC) w.e.f. the session 2016.
 - (b) M. Tech.(ECE) with specialization in Communication Engineering (CE) should also be restarted w.e.f. the session 2016.
 - (c) Similarly in place of integrated M.Tech.(IT) with specialization in WCE and PhD should be discontinued and Integrated M.Tech. -Ph.D. programs in both the disciplines mentioned above should be started w.e.f. the session 2016. The proposed scheme for both these programs is:

Admission with Financial Assistance:

The scholars admitted to the Ph.D. programmes (Full time) are eligible under the following regulations:

- a) The scholars should work for 8 hours per week to earn this assistantship.
- b) Renewal of assistantship every semester will be contingent on enrolment, satisfactory progress in research work and good performance during the preceding semester in the discharge of responsibility as teaching / research assistant.
- c) Quantum of financial assistance is as per the Government order in this regard

Eligibility for Admission and Reservation of Seats

The admissions to the *dual degree M. Tech. –Ph. D. and M.B.A. -Ph. D. programmes* are made once in a year for the odd semester. Admissions to the MBA- Ph.D programme are normally made in March-April for the next academic session through Institute Admission Advertisement. Admissions to the M. Tech. – Ph.D programme are normally held in June-July for the odd semester through CCMT counseling.

The "specified minimum" marks/CGPI (Cumulative Grade Point Index), referred to in subsequent sections, implies a minimum of 55 percent marks /6.5 (on a 10 point scale) as long as it is not less than the minimum pass marks/CGPI; otherwise, the "specified minimum" marks/CGPI implies the minimum pass marks/CGPI.

The number of admission that can be made to any programme shall be as decided by the Senate from time to time.

Reservation of seats for various reserved categories shall be as prescribed by the Board of Governors.

Candidates belonging to the Scheduled Castes/Scheduled Tribes who have passed the basic qualifying degree are eligible to apply irrespective of the marks/CGPI and will be considered for admission.

For M. Tech. –**Ph. D. dual degree:** The applicant must have a valid GATE score card in the relevant branch of engineering viz. Electronics Engineering, Computer Science, Information Technology etc., bachelor's degree in engineering or a master's degree in science with marks/CGPI not below the specified minimum. For admission into M.Tech. (IT) programme with specialization in Bioinformatics, applicants having bachelor's degree in pharmacy/medicine with marks/CGPI not below the specified minimum may also be considered. The requirement of a GATE score is waived for M.B.B.S. degree holders.

For M. B. A. –Ph. D. dual degree: An applicant must have a valid CAT score and Bachelor's degree in Engineering with minimum 60% marks/7.0 CGPI or An applicant with valid CAT score and M. Sc.
