In this regard, special attention should be paid to the following points :-

- 1) The **Internet Copy** (Certificate Format) of **Income Certificate**, **Caste Certificate** and **Domicile Certificate** with proper and complete details are only acceptable.
- 2) Fields for **High School & Intermediate Roll No. and marks obtained**, as well as **Bank account details** are **NOT EDITABLE**, hence these fields should be filled with utmost care.
- 3) **Courses** to be filled according to the list attached as **Appendix 'A'**. If the branch is not specified, leave the field blank.
- 4) The **fee** is to be filled according to the list attached as **Appendix 'B'**.
- 5) Hostel and Mess Charges are **NOT** to be included in the fees.
- 6) Students of Fifth year of B.Tech-M.Tech Integrated program, M.Tech and Ph.D. should not fill the form as they are already in receipt of Stipend from the Institute. If, they still fill the online form, it will be rejected.
